 The Wisconsin Lottery was created in 1987 after a constitutional amendment was passed to authorize it. Since its first day of ticket sales on September 14, 1988, proceeds from the Lottery have been used to fund property tax relief for Wisconsin homeowners.

Some interesting facts

- Wisconsin Council on Problem Gambling (WCPG): The Lottery
 has a long-standing partnership with the WCPG, the state's leading
 resource for gambling disorder information and support. The
 Lottery commits funds to support the WCPG's education and
 outreach efforts.
- The Wisconsin Lottery's responsible gaming efforts with the WCPG began with a public awareness campaign starting in 1998.
- The Wisconsin Lottery participates in the March Problem Gambling Awareness Month campaign, September Responsible Gaming Education Awareness Month, and the Gift Responsibly campaign in November and December.
- The Wisconsin Lottery encourages responsible gaming awareness throughout the year with posters, website messaging, and other literature.

Level 2 Certification

Wisconsin's Responsible Gaming Journey

WLA Level 2 Certification

- The Wisconsin Lottery applied for level 2 certification in 2022.
- The Lottery submitted their recertification for level 2 in September 2025.
- The Lottery had gone through major changes in staffing and felt that recertification at level 2 would be best to acclimate the team to the responsible gaming program.
- Recertification started with a review of the original responsible gaming certification document by the newly formed Responsible Gaming Committee.
